

**Chagrin Valley Ski Club Trip Agreement Updated 8/28/22**

Unless otherwise noted all prices are per person double occupancy. All trip reservations require your agreement to this form and to the waiver in the on line registration document. Please not which CMSC club you belong to.

Payment will be accepted either by check payable to CVSC and mailed within a week of signing up ( or you may loose your spot on the trip ) or by an electronic transfer via Zelle. (see QR code below) No post dated checks will be accepted. **You will be considered register until payment and online registration are received.**

CANCELLATION AND/OR CHANGES: CVSC reserves the right to (1) withdraw the trip; (2) refuse, to accept or retain a person as a trip participant; (3) prior to departure, make changes to the published itinerary, when in the club's sole judgment conditions warrant.

**FUEL SURCHARGES:** Have been taken into consideration when pricing this trip. However additional surcharges beyond the contracted ground transportation's ability to predict may arise. It is the participant's responsibility to pay such increases as mentioned in the Waiver.

SINGLE SUPPLEMENT: Room rates are based on double occupancy. If you prefer a single room you will make those arrangements with the stated hotel. If you would prefer a roommate, but do not have one, the club will make an effort to pair you with a roommate of the same gender. If a roommate is not available you will be solely responsible for the cost of the room each night.

RESPONSIBILITY: For the Holiday Valley/HoliMont trip you are responsible for calling the Wingate Hotel and making your own reservation from a block of rooms in Chagrin Valley Ski Club's name for the group rate to apply. Please notify the trip coordinator of the names for the room you reserved.

REFUNDS: Applicant will receive a full refund if CVSC cancels the trip, except and unless such cancellation is necessitated or caused, either wholly or in part by applicant's cancellation or failure to make timely payment 1) where applicant cancels at any time prior to 12/28/22 and trip departs 100% filled, the applicant may be entitled to a refund less a \$20 service charge. 2) Where applicant cancels and the trip departs less than 100% filled the applicant may be liable for up to \$111.

NSF CHECK or NSF Zelle: For any payment returned for insufficient funds, the participant will be accessed the current rate at the Clubs bank for the return fees, plus any daily penalties incurred by the CVSC. The return of any payment will be cause for cash payments to be made to the CVSC Trip Coordinator. The Trip Coordinator will notify the participant and allow him/her 14 days to cover the payment and the fee. If the funds have not been paid in the allotted time, the CVSC board may make any decision deemed appropriate, regarding the membership or loss of participation in club activities or trips in the future.

NOT INCLUDED: Any items not specifically mentioned as part of a trip, such as meals, transportation to the point of the trip departure, parking lots used, etc. are the sole responsibility of the participant.

SEPARATE CVSC RELEASE and WAIVER: requires participant's signature and return with this Application.

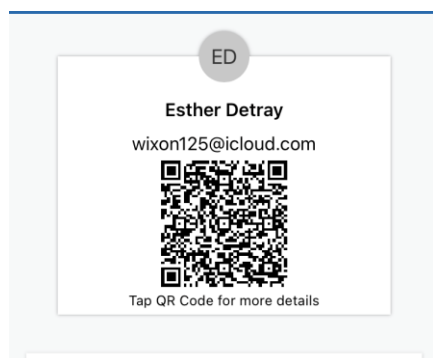

#### COVID Notes:

The CVSC leadership is excited to offer you this new multi day weekday trip to Holimont and Holiday Valley while things definitely seem to be getting better on the Covid front, there is still the threat of new variants and possible restrictions in New York. We want to conduct bus trips in a safe and responsible manner. Since social distancing is not possible in a bus situation and some participants might not be vaccinated, we recommend bus riders wear face masks. Some members may not want to wear masks, however we request you please respect each other and try to follow the mask policy on the bus. If you are opposed to this we suggest you wait till the trip has 30 participants signed up and then we will be able to offer all the groups deals for those that wish to drive up on their own. This policy will be updated 30 days prior to departure.

If you do not feel well, you are coughing, could have possible been exposed to someone with COVID, Flu, or have a cold, PLEASE notify the Trip Coordinator to discuss options. Since this may be a last minute decision. It is like all other last minute cancellations, you may be liable for the bus portion and you will need to discuss costs of your room with your roommate.
